



hereinafter collectively called THE TRUSTEES (Which expression shall, unless specifically excluded by or repugnant to the context, be deemed to include them and the Tru tees for the time being under these presents and their survivors and successors) of the OTHER PART.

WHEREAS THE FOUNDER/SETTLOR is desirous of endowing a sum of Rs.51,000/- (Rupees FIFTY ONE THOUSANDS only) for the public charitable objects and purposes upon the Trust here-in-after provided.

WHEREAS THE FOUDER/SETTLOR is further destrous of endowing all other sums for and on account of above mentioned endowment and all other moneys, properties, shares and securities which may further be acquired or collected or received by the Trustees herein above referred to or any of them as donations or subscriptions under the powers for that purpose hereinafter contained, for the public charitable objects and purposes upon the Trust here-in-after provided.

AND WHEREAS THE TRUS EES, at the request of the founder/settler, have agreed to act as TRUSTEES for the management of the said endowment in the manner pereinafter provided.


NOW THIS TRUST DEED WITNE SETH that for effectuating his said desire and for his diverse, good and lawful causes and considerations the founder and settler doth hereby transfer, assign and make over to the Trustees the sum of Rs.51,000/- (Rupees fifty one thousands only) and the

AND it is hereby declared and agreed that the FOUNDER/SETTLER hereby delivers to the TRUSTEES, who shall hold and stand possessed of the said sum of Rs.51,000/- (Rupres Fifty one thousands only) and the investments for the time being representing the same and all other further moneys, properties, assets and securities which may be acquired, collected or received as donations or subscriptions or otherwise by the Trustees or any of them under and by virtue of these presents (all such moneys, properties and securities for the time being representing the investment are hereinafter collectively called the TRUST ESTATE) and the income thereof upon trust and within and subject to the powers and provisions and conditions hereinafter declared and/or expressed concerning the same in this deed, as follows:

- NAME: The name of the Trust shall be SRI KASHI GODAVARI MEMORIAL CHARITABLE TRUST.
- 02. OBJECTS: The Trustees shall apply the net income of the trust estate including voluntary contributions and subscriptions, if any, received by the Trustees, which are in the nature of income (after payment of rates, taxes and all other outgoings, if any, in respect of the trust estate), in cash and/or in kind, for public charitable purpose. In particular and without prejudice to the generality of the foregoing, the Trustees shall be at liberty to apply the net income of the Trust Estate for any one or more of the following objects and purposes:
- (a) to undertake, organize, arrange for financial assistance, help, aid, donation and to do all acts and deeds possible for marriage of marriageable age girls of economically and socially weak parents in the society at large directly an I/or through dedicated social/charitable organizations of repute active in the Society at large.
- (b) to develop among Indian girl in general and girls from semi-urban and rural areas in particular, a sense of dignity, dedication, independence, discipline, straight forwardness and the unity of India and a spirit of comradeship to destroy all social, communal, religious and provincial prejudices.



- (d) To set-up, run, operate, assist, ur dertake, manage various technical institution to impart necessary technical, practical, job-oriented education in different fields in order to bring economic sustainability of the people. Also to organize and undertake basic education for the children of weaker section in general and girl child of the weaker section in particular.
- (e) To establish, maintain, support, help, assist, supervise, run, operate, manage and organize homes for poor and needy, destitute, orphans, old age, deserted and widow women, night shelters for home-less poor and to do all acts, deeds and things for their relief and uplift. Also to arrange for literacy of illiterate eleers, particularly women constituent of the Society.
- (f) To take -up all matters relating to general welfare in different towns and villages including Cleanliness, Waste/garbage collection and Disposal, Public Primary Health Social Congregation in order to provide relief to the suffering people in general and women in particular.
- (g) To Liaison with Government other NGO's, Private Sector Organizations, Public Sector Uncertakings and Departments etc. for development of skill, creativity, self-reliance, technical expertise etc. for all round development of the children of the Society in order to make them good citizens and for this to organize various events, camps, seminars, workshops etc.
- (h) To make educational facilities available in urban, semi urban and rural areas for all persons in general aid girls in particular and to provide all sorts of facilities conducive for educational development and progress of urban, semi-urban and rural intellectual students irrespective of sex, religion, caste and creed.
- (i) to participate in and co-operate with, as far as possible, match making efforts of various social organization, arrange for time to time PARICHAYA SAMMELLAN of marriageable girls and boys of

different social groups in Bihar and promote similar efforts being carried on elsewhere in India and al road.

- (j) to impart education to persons belonging to all classes, creeds and communities, irrespective of sex, by establishing, starting, conducting, organizing, participating, co-operating, franchising, taking-over, amalgamating, managing and running pre-primary, primary, secondary Schools, Colleges (Pre Degree and Degree), Special Schools and Institutions for all sections and age groups of Society with emphasis on Children (boys and Girls) of weaker sections of Society, Special and vocational courses suitable for the purpose and well being of the overall Society
- (k) to establish, run and manage board ng houses and hostels for boys and girls of different age groups, studies, occupation and income groups.
- (I) to start libraries, organize courses of studies, oral lectures, publish books, pamphlets, brochures, ssuing, printing and publishing periodicals, daily papers, magazines or other printed, hand written and/or cyclostyled papers, intended to advance educational, Social and Cultural values in all their branches.
- (m) to create trusts, collect funds, seek grants, reise loans and to utilize the resources, financial or otherwise, and any surplus there from in furtherance and achievement of the objects of the Trust.
- (n) to assist and promote training and research in different areas of knowledge, including all branches of arts and sciences and to preserve and inculcate amongst students the essential value and ideals of Indian culture and way of life.
- (o) to grant donation, loans, subsidies, scholarships, monetary assistance, persons from rural areas in particular for their lower/ higher/ start in life.
- (p) to acquire either by purchase, exchange, lease, gift or otherwise and to hold, sale and receive money, convey, assign, lease, exchange and administer property, both movable and immovable, in any part of India and to administer and utilize all such property wholly and

- (q) to lay out and prepare for building purpose any land (s) acquired by or leased to the trust and to erect and construct buildings of any and all kinds upon any such lands as aforesaid and to alter, pull down, improve, decorate, maintain, furnish and to do any other works on or for or in respect of all or any buildings in which the trust may be interested.
- (r) to sell, lease, exchange and otherwise transfer for consideration, all or any portion of the properties, a sets and liabilities of the trust to any other trust or society or person(s).
- (s) to enter in to agreements and a rangement with various departments and ministries of the Central and State Governments of India, International and national finarcial and developmental institutions and organizations, Government, Societies, associations, persons and NGO's of other Countries for securing grants-in-aid, loans and/or any financial help or assistance for all established and amalgamated institutions under the trust.
- (t) To incur and spend expenses for the maintenance, welfare and reproductivity of animals and birds, whether domestic, orphan or wild and to establish, support, run, maintain and grant-in aid for Goshala, grazers, reproductive centers, lest stands, healing centers, research centers, hospitals and other places established for maintenance and welfare of all types of animals and birds.
- (u) To establish, support, maintain and grant-in-aid public charitable institutions, activity projects in rural areas for economic, educational and social development, health and family welfare, open and maintain rest houses, parks and recreation grounds and to provide for fresh drinking water in rura and urban areas to all needy people and to take steps and spread knowledge for water source management and conservation of water.
- (v) To establish, support, maintain, run or grant-in-aid hospitals, medical schools and colleges, nursing somes, babies homes, anath ashrams and such other institutions of societies for public benefit as the

Trustees may think fit and proper for the purposes of relief or aid to the society at large.

- (w) To grant relief on the occasions of earth quakes, floods, famines and other occasions of natural calamities and general distress and to give donations to other institution or institutions doing similar relief work;
- (x) To establish, maintain, promote and assist institutions having public charitable objects and objects similar to this trust and give donations for public charitable purposes as the Trustees may in their absolute discretion think fit and also to make grants for the benefit of the employee or employees of the trus;
- (y) To do such other public charitable work as the Trustees may from time to time think fit.

Provided that if any one or more of the objects specified in these clauses are held not to be objects of public charitable nature, the Trustees shall not carry out such object or objects, but the validity of the Trust created by these presents as a Trust for public charitable purpose shall not be affected in any manner.

For the purposes of these presents, the expression "Charitable Purpose" shall have the same meaning as is a signed to those expression in the Income Tax Act, 1961 or any statutor, modification or enactment thereof for the time being in force.

03. TRUSTEES:

(i) The total strength of the Trustee shall at no time be less than three and for the time being not more, han twenty five. The number of Trustees can be increased with unanimous decision of the Trustees to any upper limit. The Trustees appointed here-in-above are family Trustee and one person from his or her direct family will be appointed/co-opted as trustee after death and/or resignation on health ground, if prior nomination to this effect is received from him her and so on. Other Trustee(s) appointed/co-opted, if any, as the case may be from time to time, will be Trustee(s) for life and entail no right or authority whatsoever to appoint, nominate, assign or in any manner transfer trusteeship within or after his/her life to anybody else.

(ii) The majority of the Trustees shall have the powers to fill in the vacancy in the office of the Trustee caused by death, resignation and removal.

Provided, however, that the incumbent is fulfilling the qualification provided here-in, and

Also Provided that during the life time of the founder, his prior consent be obtained in writing before such appointment;

- (iii) The Trustees shall resign his/he office or shall be deemed to have vacated his/her office if he or she, as the case may be, is requested to resign by all other Trustees in a case when the trustee concerned is guilty of misconduct and an offence under the laws of the land.
- (iv) No person being (a) un-discharged insolvent, (b) convicted of an offence involving moral turpitude, (c) unsound mind, (d) a minor, shall be eligible to or continued to be as a Tristee;
- (v) The surviving or continuing Trustees shall have the right to act notwithstanding any vacancy in their body;
- (vi) A new Trustee shall be appointed by a resolution passed with the 3/4th majority decision of the Trustees and u on payment of Rs. 51,000 (fifty one thousands) in cash to the funds of the Trust, whereupon the trust property shall—suo moto vest in such Trustee along with the other Trustees for the time being and he/she shall thereafter be subjected to all the duties and be entitled to all the rights of Trustees, with effect from the date of passing of such resolution. Provided, however, that any fraction of strength will be rounded to one for this clause.

04. POWERS, RIGHTS AND DUTIES OF TRUSTEES

The powers, rights and duties of the Trustees shall be as follows:

(a) The Trustees may accept any denation or contribution in eash or in kind (other than partly paid shares of any company) from the founder/settler or any other person or persons, firm or company for the furtherance of the objects of the Trust. The Trustees may also take over the management of any public charitable, humanitarian and/or non

- (b) The Trustees may raise and borro v money required for the trust estate on bonds, mortgages, pledge, bills of exchange, promissory notes or other pobligations or securities, founded or based upon all or any of the properties, including the rights of the trust, or without any security and upon such terms as the trustees in their absolute discretion think fit and to pay out of the funds of the trust all expenses of or incidental to the raising of money for the trust, including brokerage or commission.
- (c) The Trustees may take over the management and administration of any other society, organization, institut on or trust having objects wholly or in part similar to those of this trust or such terms and conditions as they may think fit and manage the same accordingly;
- (d) The Trustees shall, from time to time, after meeting the expenses of and incidental to the management of he Trust and its properties under the trust, decide the particular object or a bjects for which the income or the corpus of the trust properties for the time being available shall be applied;
- (e) In the administration of the trus, it shall be open to the Trustees to give the relief which they are authorized to do, by making donation, assistance, gifts in money or in kind in order to achieve the objects of charity above mentioned, but not exceeding such sum to each individual case as the Trustees may from time to time fix, on such terms and conditions as the Trustees may in their absolute discretion think fit;
- (f) The Trustees shall cause proper books to be kept wherein shall be entered a true and accurate account of all moneys received, disbursed or spent in connection with or in the course of management of the Trust premises or in relations to the carrying out of the objects and purposes hereof as well as of all assets, credits and effects of the Trust estate. The accounts shall be regularly audited by Chartered Accountants, being appointed every year by the Trustees to hold office as such upon a remuneration payable by the Trust.
- (g) The Trustees may at any time of times at their sole discretion call in and convert into moneys such parts of the Trust fund as shall not consist of money and shall stand possesser of the moneys produced by such calling in and conversion of such part of trust estate as shall consist of

money and the investments for the time being representing the same upon the trust and with subject to the powers and provisions herein before declared and contained concerning the Trust fund;

- (h) The Trustees may sale the Trust Estate or any part thereof either together or in lots and either by auction or private contract and either with or without special stipulations as to title or otherwise for replacement of new assets for assets forming part of Trust Estate or rescind or vary any contract for sale or resale, without being answerable for loss occasioned thereby and may for the purposes aforesaid or any of them, execute and do all such assurances and things as they shall think fit and shall, out of the moneys which shall arise from any such sale as aforesaid, pay the expenses incurred in the same or otherwise in or about the execution of any of the trust objects or powers of these presents and may invest the net sale proceeds in the securities and investment as hereby authorized.
- (i) The Trustees may manage or superintend the management of any lands, hereditaments and premises for the time being comprised in the Trust estate or any part thereof with power to erect, pull down, re-build and add to, alter and repair houses and other buildings and to construct drains, roads and fences and otherwise to improve and develop and to cultivate or cause to be cultivated land of farm, all or any of the said lands, hereditaments and premises and to insure houses and buildings against loss or damage by fire or other risk or to let, make allowances to and arrangements with tenants, agriculturists and others and accept surrenders of leases and tenancies and generally to deal with the said lands hereditaments and premises as if they were the absolute owners thereof;
- (j) The Trustees may at their absolute discretion demise any lands, hereditaments and premises for the time being comprised in the trust estate or otherwise either at rent or by taking a fine or premium either subject or not subject to stipulations as to repairing or building and to grant any lease or leases and licenses subject to such covenants and conditions, such as progressive or other rents and otherwise, in such manner and form in all respects as the trustees may think fit and proper and may enter into any contract or contracts for the granting of any such lease or leases as aforesaid and also to rescind or abandon or vary the terms of every or any of such contract which may have been entered into for any such lease or leases as aforesaid, upon such terms and conditions as the trustees may think fit and any money to be received as a fine or premium for the granting of any such lease as aforesaid shall be held upon such trusts, as

mortgage of immovable properties of in or upon stocks, mutual fund units, debentures or any other securities authorized by the Indian Trusts Act, 1882 and the Income Tax Act, 1961 or in deposits with any company, bank, and the Income Tax Act, 1961 or in deposits with any company, bank, person or firm, as they may think proper with power to sell/dispose-off the same and or to alter, vary or transpose such investments from time to time in such manner as they may in their absolute discretion think fit, for other investments of the same nature or otherwise. Without prejudice to the general powers herein contained, the Trustees shall have power to purchase and or sell. Government securities of all kinds and these may be held in the name or names of all or any one or more of the Trustees;

Provided, nevertheless, that nothing herein contained shall authorize or shall be deemed to authorize the frustees to invest the trust funds in deposit with or loan to any company, bank or person or firm to which the settler and or the Trustees may be interested;

- (1) The Trustees may constitute so the working or managing committees consisting of Trustees or some of them with other reputed individuals of the society for the management of the affairs of the Trust estate for carrying out the objects or purposes hereof or any matter relating thereto and delegate to such committee or committees any of the powers vested in them and to vary or regulate the same from time to time. However, all such committees and/or sub-committees shall work within the overall supervision of the Trust Board and for all acts and deeds of those committees and/or subcommittees, the Trust Board shall be held responsible and/or answerable.
- (m) The Trustees may compror ise, compound, abandon, submit to arbitration or otherwise settle any dept, account, claim, suits, proceedings or disputes whatsoever relating to the trust Estate or any part thereof;
- (n) The Trustees may frame schemes, bye-laws, rules and regulations to conduct their meetings, for the appointment of a managing committee or working committee for carrying out the objects and purposes of these presents and otherwise for giving effect to the objects and purposes hereof and to vary and aid to or modify the same from time to time as the trustees may in their discretion deem fit and proper;

- (o) The Trustees may open and operate account or accounts, whether savings, fixed, current or overdmit, in the name and for the purpose of the Trust with any Banking organization as the Trustees may deem fit and proper and to endorse Government premissory notes and other securities, hundies, cheques and other negotiable is struments from time to time;
- (p) The Trustees may authorize any one or more of the Trustees to operate the banking account, to endorse shares and Government securities or to do any other ministerial act, deed or thing on behalf of the Trust
- (q) The Trustees may appoint secretaries, managers, lawyers, solicitors, architects, engineers, surveyors, gumastas or other employees for the purpose of management and supervision of the Trust Estate, for collection of rents, dues and profits, for keeping the accounts and records and for other purpose of the Trust;
- (r) The Trustees may associate good people from the society in the capacity otherwise than the Trustees. The Trustees comprising the Trust Board can devise for induction of a ch people in the Trust as ordinary members and life members on such qualification as may be unanimously declared in the form of bye-laws of the Trust by the Trust Board and which can be amended to and modified from time to time as may be decided by the trustees:
- (s) The Trustees may amalgamate the Trust Estate or any part thereof with any other Trust of a public charitable nature having objects and purposes similar to the objects and purposes of these presents;
- (t) The Trustees shall have the right to reimburse themselves and pay and discharge out of the Trust Fund. Il expenses incurred in or about the management of the Trust property, the execution of the Trust or any of their duties under these presents;
- (u) The Trustees may nominate, constitute and appoint constituted attorneys or agents and to delegate to such attorneys or agents powers with regard to the management of the Trust Estate and all matters and affairs relating thereto or for the purposes of carrying out the objects and purposes thereof or for collection and realization of the rents and profits of the Trust Estate or any part thereof or to operate on any accounts with a Bank or Banks and to conduct appeal in or defend any cause of action on behalf of the Trust before any civil, criminal, revenue, tax(including

- (v) The Trustees shall have the right to advance to individuals, institutions, societies etc. engaged in activities of animal and bird welfare, humanitarian, educational, social, health and family welfare, sports and recreation, public religious or other nature of general benefit on such terms as the Trustees may in their discretion think fit;
- (w) The Trustees may by an unanimous resolution, register a charitable Society under the Societie Registration Act, with the objects similar to this Trust and to which upon registration, all the assets and for incomes forming part of the Trust property may be transferred and regulations whereof shall be in conformity with the provisions of this Trust with such modifications as may be agreed to by the Trustees;
- (x) The Trustees may by issuing receipt of the Trust for the sale consideration money received of any of the lands, hereditaments and premises for the time being comprised in the trust or any part thereof hereby directed or authorized to be so dor for any other moneys, securities or investments paid, delivered or transferred to the Trustees by virtue of these presents shall effectually discharge the person or persons paying, delivering or transferring the same there from and from being bound to see to the application thereof;
- (y) The Trustees shall be respectively chargeable only for such property, moneys, funds and securities as the shall respectively actually receive, notwithstanding their respectively against any receipt for the sake of conformity and shall be answerable and accountable only for their own respective acts, receipts, neglects or defaults and not for those of each other or for any Banker, Broker, Auctioneer of other person with whom or into whose hands any Trust moneys or accurities may be deposited or come in any manner either for dispensing wholly or partially or protection of the title of the lesser to any property or for the deficiency of any funds or securities or for any other loss, unless the same shall happen through their own willful default respectively.

Unless and until altered or varied according to the provisions contained in clause 4 (n) hereof, the following rules and regulations shall apply as to 4 the conduct of the business by the Trustees and the meeting and procedure of the Trustees:

- (a) The Trustees may appoint one of them as managing Trustees on such terms and conditions as they may decice. The managing Trustee shall be the Chairman of the Board of Trustees, In case there be no managing Trustee, the Trustees may appoint one of them as the Chairman of the Board for such period as they may decide. The first Managing Trustee shall be SRI RAMGOPAL, who shall hold this office until his death;
- (b) Subject to clause 5 (a), the Managing Trustee shall hold office for such period for which he/she may be appointed and shall continue to act as such until appointment of anothe Managing Trustee notwithstanding the expiry of the period of his/her appointment.
- (c) The office of the Trust shall be ituated in the State of BIHAR or at such place or places as the Trustees may from time to time determine;
- (d) The Managing Trustee himself of the Secretary of the Trust under the authority of the Managing Trustee may issue notices convening the meeting of the Trustees;
- (e) The notice of the meeting of the Trustees and all other communication shall be sent to the Trustees at their ad tress registered for the time being in the office of the Trust;
- (f) The three Trustees will form a quorum;
- (g) All matters arising at or dealt with at the majority meeting shall be decided by majority of votes and in ca e of equality of votes, the Chairman shall have a second or casting vote;

Provided, However, if the matter relate to the sale of any property, movable or immovable, belonging to the Trust, o making or changing an investment whether in movable or immovable property and appointment of a trustee on the board of trustees, the same shall on y be recided by a majority of three-

Provided further that, if any of the resolution as mentioned in 1st proviso above comes before the meeting of the trustees, every trustee must be present in the meeting of the board of trustees, if validly convened. If one or more trustees are not attending and for that reason the resolution could not be taken-up and decided, then the meeting shall stand adjourned for the next working day at the same time and place and/or a day fixed by the trust board in the adjourned meeting itself and a fresh notice to this effect is given to all the trustees including the trustee(s) not present in the meeting. In the reconvened meeting again if the subject resolution could not be taken-up and decided for want of presence of one or more trustees, then the subject resolution will be taken-up and decided, treating the trustees present and voting in the meeting as the total strength of the board of trustees for the time being.

- (h) If at any meeting, the Chairman is not present within fifteen minutes of the time appointed for the purposes of holding the meeting, the Trustees present shall elect one of hemselves to act as the Chairman of such meeting;
- (i) A meeting of the Trustees at which a quorum is present shall be competent to exercise all or any of the authorities, powers and discretions vested in them by or under this deed or otherwise exercised by them;
- (j) A resolution in writing circulated among all the Trustees and signed by a majority of them present in India shall be as valid and effectual as if it had been duly passed at a meeting of the Trustees duly called or convened.

06. RETIREMENT OF TRUSTEES

Any Trustee may retire at any time without assigning any reason and without being responsible for any costs occasioned by such retirement.

07. MEETING OF THE TRUSTEES

All the Meetings of the Trustees shall be held in the manner as below:


